A renewal application must be submitted no later than 30 days prior to the expiration of the existing permit. A renewal application must contain the same information required for the initial application, must be accompanied by the fee required and must be submitted to Code Enforcement. It is the homeowner's responsibility to renew this application annually.

The Code Enforcement Officer is authorized to make inspections from time to time to determine the condition of the rental units and to safeguard the health, safety, morals and welfare of the public. The Code Enforcement Officer may revoke a permit at any time if a rental unit is found in violation of the Applicable Laws that, in the opinion of the Code Enforcement Officer constitutes a detriment to public health safety and welfare to the people of the Village of Monticello and/or if there are repeated occurrence.

The filing of this statement does not confer any rights to rent or use apartments that were not constructed in accordance with the Code of the Village of Monticello, the Building Code of New York State, the Monticello Rental Law or any other applicable ordinances or laws and for which a Certificate of Occupancy has not been issued.
