**VILLAGE MANAGER'S REPORT**

**Telephone Billing Review**

The Village Manager reported that a company is reviewing the telephone bills to find out whether the Village is being charged correctly.

**Relocation of the Skate Board Park**

Manager Barbarite announced that he is planning on relocating the Skate Board Park to deHoyos Park as he feels it is a more appropriate location and to provide more room in the parking spaces for businesses when the Broadway Project begins and parking will be prohibited on Broadway.

**Demolition of Head Start Building-Dillon Road**

The Village Manager announced that the Joint Monticello Fire Department has agreed to do a "controlled burn" to demolish the old Head Start building located on Dillon Road. He explained that the building is beyond repair and the firemen will use it as a training exercise and after it is leveled the Sullivan County Partnership has agreed to pay landfill "tipping" fees.

**Use of Tasers by the Monticello Police Department**

Police Chief Solomon informed the Board that he is considering the use of tasers by supervising police officers as an Alternative Method For Deadly Physical Force. He will be updating the Board and meeting with them individually to view an instructional video.

**PUBLIC COMMENT - AGENDA ITEMS ONLY**

**27 North Street**

Ray Lustig, owner of 27 North Street felt there should be segregation of responsibilities from the Village Manager's Office and the Building Department as mentioned in the letter from the State Building Department.

**Cost of Architectural Engineering Services Proposal**

Betty Friedland questioned whether the Village should be spending \$22,700 of taxpayers' money to pay for a study of this type.

The Village Manager responded that the Village Hall has been neglected for many years and needs a study to determine the best use of the space, conservation measures such as new windows to prevent heat escaping, air conditioner efficiency, and recommendations on using the old bays in the former fire department for the police department and as a youth building which would allow the seniors to have more space in the Ted Stroebele Recreation Center.

**Relocation of Village Board Meeting**

Betty Friedland again was concerned that since the Village Board meetings are attended by many more people than in the past and she felt the location of where the Board meetings are held should be moved to the Ted Stroebele Recreation Center to accommodate everyone.

**Nomination To The Congressional Youth Leadership Council**

Shane Jackson, a Village resident and a 7<sup>th</sup> grade student at the Robert J. Kaiser Middle School announced he has been nominated to represent his school and community as a member of the National Young Leaders State Conference (NYLSC) in Albany. He explained that his participation in the NYLSC depends on whether he can raise \$1,500 in sponsorship.

Mayor Jenkins encouraged everyone in attendance this evening to donate money towards this outstanding cause.

The Village Clerk collected the generous donations and announced that anyone wishing to contribute to Shane's trip could leave their donation with her and she will be contacting him with the proceeds.

**WHEREAS**, it is in the best interests of the health, safety and welfare of the citizens of the Village of Monticello for the Monticello Waste Water Treatment Plant to function within the Village.

**RESOLUTION ACCEPTING PROPOSAL FOR ARCHITECTURAL ENGINEERING SERVICES FOR RENOVATION OF VILLAGE HALL BUILDING IN THE AMOUNT NOT TO EXCEED \$22,700**

**WHEREAS**, the Village Hall Complex located at 2 Pleasant Street is in dire need of renovations to produce a more efficient layout and flow of operations in the facility; and,

**WHEREAS**, some of the space has become available since the fire department relocated to their new complex to allow the expansion of the police department and youth programs; and,

**WHEREAS**, Barton & Loguidice have submitted a proposal to the Village that the Scope of Services for a time and expense fee not to exceed Twenty Two Thousand Seven Hundred Dollars (\$22,700) for the services described herein as follows:

- a. Existing Building & Building System Evaluation - \$6,900
- b. Asbestos Pre-Renovations Survey: \$3,300
- c. Space Planning & Functional Program: \$7,100
- d. Conceptual Design, Opinion of Probable Construction Cost Estimate and Phasing: \$5,400

**RESOLUTION AUTHORIZING THE VILLAGE CLERK TO ADVERTISE FOR REQUESTS FOR PROPOSALS TO PERFORM TITLE SEARCHING SERVICES TO ASCERTAIN THE OWNERSHIP OF EACH PARCEL OF REAL PROPERTY ON BROADWAY**

**WHEREAS**, New York State Department of Transportation is commencing a reconstruction project of Broadway in Monticello, New York, which shall include extensive work on the sidewalks located on Broadway; and

**WHEREAS**, it is necessary to ascertain which portions of the sidewalks on Broadway are owned by the Village and which parts are owned by private property owners in order to insure that the Village and/or the New York State Department of Transportation has the legal authority to enter onto said sidewalks for the purposes of reconstruction of said sidewalks; and

**WHEREAS**, the Village Attorney has recommended that the Title Search Company be bonded to protect the Village from a future

**NOW, THEREFORE BE IT RESOLVED,** that the Board of Trustees of the Village of Monticello does hereby authorize the Village Clerk to advertise for Requests for Proposals to perform the title searches to ascertain the ownership of each parcel of real property onto which the Village and State must enter to complete the Broadway sidewalk reconstruction project.

**PUBLIC COMMENT**

**Expansion of the Landfill**

Janet Newberg asked that the Board not repeal the local law to allow the Sullivan County Landfill to expand. She indicated that this local law was adopted to protect the safety and welfare of local residents.

**27 North Street**

Ray Lustig, owner of 27 North Street, was concerned that the Village Building Department has not submitted their annual report of their activities to the Secretary of State as required by law.

Trustee Schoonmaker asked that Mr. Lustig meet with Village officials to resolve the problems. He noted that the Village is obligated to protect its residents and he wants to see evidence that the building owners are cooperating to comply with the building codes.

Beverly Santarelli explained that she has been in Mr. Lustig's building at 27 North Street prior to it being shut down by the Village and it was a bug infested firetrap and no one should have lived there under those conditions.

Marie Ng was concerned that someone is living on the 3<sup>rd</sup> floor as she has seen someone coming out of that building. She also noted that when people were living in that building they were parking illegally in her husband's parking lot behind that building.

Mr. Lustig responded that if this is the case these vehicles should be ticketed or towed away.

### **Fairground Estates**

Chris McLeod, President of the Fairground Estates Homeowner's Association explained that the residents of that housing complex have noticed the decline of the quality of life in their immediate residential area which they feel is being caused by the close proximity of and saturation of low income housing developments namely Horizon Apartments and Moon Manor. He described various incidents that have occurred recently between youths of both of those complexes.

Charles Stalter, owner of a single family home on Dollard Drive agreed with the vandalism and crime in the area and explained that although he bought his house last year, it is already up for sale.

### **Village Hall Meeting Room Capacity**

Betty Friedland was again concerned about the meeting room during Village Board meetings being over legal room capacity.

### **Recycling Laws**

Mrs. Stafford questioned whether the Village's recycle rules will be enforced?

Betty Friedland was also concerned about the Village not enforcing the mandatory recycling laws.

The Mayor responded that they will begin to enforce them by the beginning of September. He indicated that Ms. Friedland she call him directly and question what the Village will be doing

regarding recycling. He felt that she comes to the meeting making it sound like the Mayor is not doing anything and felt she should be more positive at Board meetings instead of looking to just meddle.

Tom Mack, a Village resident felt that if a resident has a problem they should call Village Hall and setup a meeting to iron out the problems before they air their grievances in public.

Sue Anthony referred to an article in the newspaper regarding the rejuvenation of Livingston Manor's Main Street, and questioned why this can't happen in Monticello. She felt it can happen if the residents work together and don't have self centered agendas.
