A motion was made by Trustee Marinello, seconded by Trustee Rue, unanimously approved on a roll call vote to adopt the minutes of the meeting of July 21, 2008 as presented.

The Mayor announced that the CPR group had a march from the Courthouse to deHoyos Park with about 150 attending with a picnic after to make residents aware of the violence in the Village. He explained that more marches are planned for the future. He noted that the group got a "Cheers" by the Times Herald Record editorial staff in today newspaper.

Mayor Jenkins reappointed Myrtle "Cookie" McKinney-Allen to a five (5) year term to the Monticello Housing Authority Board to expire July 31, 2013.

RESOLUTION AMENDING THE VILLAGE FEE SCHEDULE

WHEREAS, the Village has been reviewing the fee schedule regarding the installation of all new ¾" water meters for new residential and commercial building; and,

WHEREAS, it has been determined that these water meters cost approximately \$110.00 each; and,

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of the Village of Monticello do hereby amend the fee schedule as follows effective immediately.

New Water Meters - \$125.00 per meter for each installation.

Current \$15.00 - Proposed-\$20.00

A motion was made by Trustee Hutchins, seconded by Trustee Marinello, unanimously approved on a roll call vote to adopt the above resolution.

RESOLUTION CORRECTING THE 2008/09 VILLAGE TAX ROLL - SLEEPY HOLLOW DEVELOPMENT SECTION 126, BLOCK 1, LOT 3

WHEREAS, the Sleepy Hollow Development Corp. is an exempt property in Roll Section 8 of the Village Tax Roll; and,

WHEREAS, Sleepy Hollow Development is federally funded and receives Shelter Rents as such, and therefore, the Village is entitled to a portion of this money.

NOW, THEREFORE BE IT RESOLVED, that the Village Board of the Village of Monticello does hereby correct the 2008/09 Village Tax Roll to reflect the additional \$37,865.32.

A motion was made Trustee Marinello, seconded by Trustee Schoonmaker, unanimously approved on a roll call vote to adopt the above resolution.

ORDERING BILLS PAID

A motion was made by Trustee Schoonmaker, seconded by Trustee Rue, unanimously approved on a roll call vote that the bills audited by the Auditing Committee of the Board of Trustees and appearing on the Abstracts of the bills herewith submitted are ordered paid.

PUBLIC COMMENT

Economic Development

Trustee Schoonmaker explained that last Thursday the Board was invited to the Great Silver River Restaurant to meet the new owners/managers of the restaurant. He explained that while

having lunch the attendees were introduced to some individuals that are interested in investing money into their buildings in the Village. He felt that after speaking to these individuals that there is a possibility of some real changes coming on Broadway.

Napoli Building

Becky Whipple thanked the Village Manager for having the windows on the upper floors replaced in the old Napoli Restaurant building.

Business Complaint

Cindy Deitchman, owner of the Trading Post questioned why no one comes to the business owners to advise them what grants are available, or asked what the Village can do for them to help bring business to the Village.

The Mayor explained that he had visited her business, but speaking during business hours around customers was not a favorable atmosphere or private enough for that type of conversation.
