#### <u>Resolution declaring vacant the positions of Village Manager and Acting Village</u> <u>Manager</u>

A motion was made by Trustee Rue with a second by Trustee Bennett. Upon the call of the roll, the vote went as follows:

#### <u>Resolution retaining the services of Raymond Nargizian as Village Manager and Zoning</u> <u>Officer without pay for two (2) months</u>

A motion was made by Trustee Rue with a second by Trustee Solomon.

Mayor Jenkins stated that with all due respect to the Board, I just hope that with these new positions our budget does not go over the 2%. I hope that the new Board coming in stays conscious of the budget because the taxes in this Village are too high. I have been a Mayor for six (6) years in this Village and have always kept his budget at 2% and I just hope that this new Board will help me keep at 2% because we cannot afford the taxes in this Village; because with some of the salaries, I know you guys got the 4 votes or whatever it is, but be conscious of what your paying for and for the increases in taxes in this Village; taxes in this

Village are already too high. Again, since I have been a Mayor, my budget never goes above 2%, the Governor gives you 2% and I don't want to go over that.

Trustee Rue asked Mr. Nargizian if he would like to say anything because this is at no charge to the Village for two months, I want to make it clear because we need time for us to sit down and hire a Manager, so Ray offered to do it without pay for two months.

Upon the call of the roll, the vote went as follows: Trustee Rue-yea Trustee Bennett-yea Trustee Solomon-yea Trustee Weyer-yea Mayor Jenkins-nay

Mr. Nargizian stated that he would like to thank the Village Board for entrusting him with the job of Village Manager. I do not take this position lightly, recognize my fiduciary responsibility is to the tax payer and I am obligated to look out for the collective interest and I will do so. There will be no nepotism, cronyism, or favoritism under my watch. Our hiring policy will be based upon merit and merit alone. We have a priority to concern ourselves with Economic Development. We must devise a formula to fill the vacant stores on Broadway, a priority will be based on reducing crime in the Village, Code Enforcement will be fine-tuned and enforced. We will be a people and business friendly Village. For my first appointment, I will appoint Richard Baum as the Village Deputy Attorney, his duties will include being the Attorney for the Planning Board and Zoning Board and I ask this Board to confirm that appointment with a resolution tonight. I also appoint Leo Glass as Deputy Judge to the Justice Court, Acting Village Judge.

Trustee Rue commented that she is a hold-over; you have to bring it to the next meeting.

Mayor Jenkins asked the Village Attorney, Michael Davidoff, what happens to the holdover now?

Mr. Davidoff responded that the hold-over remains in until somebody else would qualify at a later time, if they don't the hold-over remains in and stays on as the Village Clerk.

Mayor Jenkins asked is that Civil Service?

Mr. Davidoff responded no, it's a Mayor's appointment approved by the Board, so she's an officer an officer's hold-over unless and until somebody else qualifies. As long as the situation is what it is, she continues on as Village Clerk.

Mayor Jenkins stated that if they get someone that qualifies, then they can get rid of her.

Mr. Davidoff replied, no it's your appointment and it has to be approved by the Board, if the Board does not go along with your appointment, she remains as a hold-over and continues until the end of your term.

Trustee Rue does he have to appoint at every meeting?

Mr. Davidoff responded no, he doesn't have to ever do it again. Until somebody else fully qualifies, she remains in and does not have to be done at every meeting.

Mayor Jenkins commented, Janine I would like to thank you and that as long as I am the Mayor and as long as I have breath in my body, you will always be appointed by me and I will always carry you as long as I am in this Village and I think you are doing an excellent job in this Village. Thank you very much, regardless if I am here Mayor or whatever,

you've done an excellent job and I with you 100%. What goes around comes around, so just keep the faith.

The Village Clerk responded, thank you Mayor.

Mr. Davidoff commented that the amount had increased for non-biddable items. The only change is the bidding amounts. I think is says 10 & 20, but I think a purchase without bids

can be higher, they raised the levels and our procurement had the lower levels. You can pass it with the amendment that you do not have to bid contract items unless they exceed \$20,000.00 and Public Works projects over \$35,000.00, you can adopt your procurement.

Mayor Jenkins stated that the reason why this Board dropped it was because the spending was a lot of unnecessary items and certain people were getting hooked up with certain jobs, doing political favors and doing things that we try to control and can run rapid with our Village tax payers' dollars. So that put a little stop on it. Again, I think the Board needs to be conscious on who's spending and where the money is going; this is not the good ole boy network where spending happens and there is no explanation.

Mr. Davidoff continued that most municipal procurements are adopted at the higher rate.
