### **Mayor's Report**

#### Village Manager's Report

Good Evening Honorable Mayor, Trustees & Members of the Public:

As you know, we were awarded a grant project for the Jefferson Street corridor through the NYS Department of Transportation. This grant is for significant drainage and sidewalk improvements along Jefferson Street. As part of the grant requirements, the project manager

for the Village of Monticello on this project, Barton & Loguidice, must hold two public informational sessions with regard to this project. The purpose of these informational sessions is to a.) Notify the public and neighboring property owners of the project and b.) Provide an opportunity for both the public and board of trustees to give input and ideas. The public information sessions are organized and run on the village's behalf by Barton & Loguidice. Since the meetings are not a function of and not run by the Village Board, the public information sessions are not considered a meeting of the Village Board and as such, are not subject to NYS Open Meetings Laws (as confirmed with Robert Freeman). This means that the entire Village Board is welcome to be in the audience and provide input without breaking any rules regarding quorums. Peter Cristiano of Barton & Loguidice had suggested the date of Tuesday, March 24, 2015 at Village Hall, with one session starting at 2:00 PM and the second session starting at 7:00 PM. The public information sessions are a precursor to any formalized engineering plans. The date was chosen so that we would have ample time to notify the public and neighboring property owners. Following the public information sessions, there will be ample time for the Village Board to provide any and all additional input with regard to the project, before formal plans are developed and prior to any necessary public hearings on the matter. In addition, following public hearings on the project, the Village Board will also have final say on the project through a formal vote to either approve or deny the project as planned. Having received majority Board consent, it is my intent to move forward with the scheduling and announcement of the 3/24/15 public information sessions.

At the last meeting of the Village Board I noted that the surplus equipment we put out to online auction with Teitsworth Auctions were unsuccessful in coming near our desired reserve prices. Therefore I have put forth a resolution for board approval that we consider changing vendors for re-auction. After research by both Highway Superintendent Jim Steinberg and I, we would like to consider utilizing Auctions International in an attempt to sell or surplus sanitation vehicles using the same reserve criteria as we did with the prior auction. The Auctions International website features better design, easier navigation tools and seems more widely utilized by regional municipalities. On a positive note, the village did receive a reasonable offer from the Town of Clarence New York for the purchase of our surplus 2008 International Packer that I have also put before the Board of Trustees for consideration on this evening's agenda.

So that the Board is aware, I have submitted a letter to NYSDOT regarding the majority of our 2014 CHIPS funding that had previously been withheld. Superintendent Steinberg and I have agreed to address all ADA deficiencies by September 20, 2015 and check for our remaining funds should be received shortly.

After receiving feedback from the Board of Trustees at the last village board meeting regarding the hiring of professional services to assist the Code Review Committee in necessary updates to our Zoning Laws, I will work with the Village Attorney to create an RFP that can be submitted for your approval at the 3/17/15 Board Meeting. Prior to that, the Code Review Committee

would like to hold a work session on Tuesday, 3/10/15, to discuss with the Board of Trustees what progress and conclusions they have made to date.

Also on your agenda is a discussion item and potential resolution to modify the current rental terms for the Ted Stroebele Center. We would like to reduce the number of hours to a maximum of 4 hours per time block with ample opportunity before the function to set up and even more to break down and clean following the event. There are currently too many people who abuse the time limits and quite frankly, they are well below what the fees are for any other venue. In addition, I am requiring that all parties renting space provide the refundable security deposit without exception. In addition, I authorized Jessi-Ann Rosenbaum to coordinate a Craft & Vendor Bazaar at the Stroebele Center on Sunday, April 19, 2015. It should be a nice event for the public, as well as, a good revenue generator for the Ted Stroebele Building. To date she has already received inquiries from over 40 unique vendors seeking to reserve a table. Each space costs \$20, which will go directly to the Stroebele Center and Recreational Funding. I have also authorized a request from Chief Mir and his wife Ann to hold at least two events at the Stroebele Center in which all proceeds would go to the Stroebele Center for necessary improvements.

On Friday, March 6, 2015 at 1:30 PM, George Popp from the USDA will be meeting with us at my office to discuss a proposal for a project that would significantly upgrade aspects of our current water infrastructure. While much of this will have to be undertaken by the village through loans, I believe that there is some opportunity to have at least a portion of the project be eligible for federal grants. In addition, the proposal is expected to include an interest rate that is well below what was initially anticipated. Between the potential for some grant funding and the lower interest rate, the village has an opportunity to stretch their dollars so that more can be achieved through this project than was previously thought.

Please remember that Friday, March 6<sup>th</sup> is national colorectal cancer awareness day and everyone is asked to wear blue to raise further awareness throughout the community.
