Mayor's Report

John Fuller, Village Engineer- Village Hall Renovations Update

Mr. Fuller presented the last stage of the Village Hall renovation plans for the Boards final review and critique. The completed renovations will consist of a shift of the Police Department into the old Fire Department bays that are being used for storage for the Highway Department, the installation of a retaining wall in order to better utilize the parking lot between the current municipal building and the old Justice Court to create at least 45-50 adequate parking spaces, the addition of two bays for the Highway Department

for equipment storage, a shift back of the Administration Office to encompass the current Police Department, the demolition of the old Justice Court and reconstruction of a Recreational Facility for Village Residents and a renovation of the meeting room in Village Hall.

The Board made final recommendations for the plans and asked Mr. Fuller to return in a few weeks with a finalized plan that can be presented for bidding.
