You all have the report of Mr. Smith in your possession in regards to his findings. We have tried to contact the owner's several times and I believe just recently over the last day or so, they have been at the premise trying to do some remedy to the situations, but at this point it's too late. The project will follow the bid process and be levied on to the taxes for payment.

I spoke with Assembly Woman, Eileen Gunther, regarding the other \$250,000.00 that was needed to fund the project and although it's unofficial, she has promised to fund the balance of the project. So, I would ask that the Board award the project to the lowest bidder, Sun Up Enterprises Inc.
