He also stated that he got a call from the Veterans' Association and there is a local Iraqi Veteran in our area that is having a hard time making ends meet for Christmas, and the Village was asked to assist in any way possible.

## **Manager's Report**

Mr. Sager stated that on January 14<sup>th</sup>, 2017 at 2:30pm he will be hosting a Community Meeting for the Monticello Community Action Network to get community input regarding ways to beautify the Village and ways to volunteer.

In regards to the Sullivan Renaissance Community Action Grant, he submitted the initial information for the first phase of the grant.

Lastly, the first Village Gateway sign has been completed and will be posted at the Jefferson Street/Raceway entrance into the Village off route 17. The Village will have to continue to raise funds to get the rest of the signs completed. It will be hung by the Village DPW.

### **Discussion-General Code Proposal**

Richard S. Baum, the Deputy Special Council stated that everyone received a packet in their folders from General Code regarding updating the Village Code. Unfortunately, this cost that we have been quoted does not include the 63 or 64 page Zoning Law that was just passed because the law was passed after the fact, but the Clerk has sent them the document and they are reviewing it. They are willing to give us a complete overhaul and make our Code more user friendly, because in the current state that it's in, I know that Michael and I use it regularly and it's a huge pain for us, so I can only imagine the trouble that the residents and others have. They will take the 40+ laws that are now just PDF's on the sight and put them where they are supposed to be and completely clean up our code, which is what it needs. Janine spoke with them and deals with the Code regularly and can also give input, I don't think the \$13,500.00 that they are asking is not a bad number for the service that they will be providing and I believe that number includes 5 to 10 books, which can run hundreds of dollars on their own.

The Village Clerk, Janine Gandy-McKinney, stated that after her conversation with them yesterday, the Village will probably be looking at another \$2,000 to \$2,500.00 expense for the additional re-zoning law. They are not looking for payment in full, initially, it will be a 20% down payment once and if the contract is signed and then we can budget the full payment or payments in the upcoming fiscal year. They also said that we can update the code yearly or bi-

yearly because we do not pass a lot of laws and that would suffice us at a reasonable rate. They are willing to come in and train at no cost to the Village and they can train as many people as we want. They are looking to have a final quote for us by the next meeting and are eager to work with the Village to make this process happen.

Trustee Rue asked, is the resolution on tonight for this expense.

Mr. Baum responded, no that resolution is for the yearly hosting and maintenance fee only.

Mr. Sager stated that as far as payment is concerned, a person of the LISCH grant can be used for it along with the hiring of an additional Code Enforcement Officer and the purchase of an up to date software program to get the Building Department up and running properly in real time.
