### **Mayor/Manager Report**

Mayor Sommers started his report by reminding the public that the Department of Public Works is down to eight (8) people and is cleaning the streets with the Vac-All as best they can.

The Village's Fall Clean-Up was a success.

In regards to the issues being mentioned on Social Media, Mayor Sommers stated that he would appreciate all of those individuals making these claims coming to a Village Board meeting or coming and talking with him if it is something really worth discussing. He stated that he feels that everyone here is doing a great job and if those that are commenting really had validity to what they are claiming, they would come forward and stop hiding on social media.

Other Board members commented that it's just best to ignore it, they are all cowards using fake names and hiding.

### **Appointment of Zoning Board Vacancy**

Mayor Sommers appointed David Komatz to the Zoning Board of Appeals for a term of five (5) years to fill the vacancy left by former Board member, Bonnie Hoffman.

## Resolution authorizing the creation of Two Assistant Code Enforcement Officer Positions in the Village of Monticello

He stated that he asked the Water Department and they told him that they do not do that, it is not part of their job or out of their job scope. So, in order for the Village not to have any issues we need to get his done as soon as possible especially with the weather and approaching so quickly.

Trustee Nikolados and Trustee Rue both responded that is their job and it is not out of their scope of work.

Mr. Lasher stated he knows that, but they are refusing to do it.
