Manager's Report

Mr. Sager stated that he just returned from a day training in Albany fir the Zombie properties, so I'm a little off pace here. I need to make Planning Board appointments here especially with Trustee Sommers no longer being on the Board and winning a Trustee seat, so I'd like to appoint Flo Donlon Nelson to replace Michael Levinson's position and Shannon Cilento to replace Gary Sommer's position. Also were all types of misunderstandings with the Monticello Housing Authority so I would like to re-state and re-appoint Darrin Raynor and Elaine Williams to fill two spots on that Board and there will be another one coming up soon. I would ask that the Board give me input on that potential appointment.

Trustee Rue asked do they all live in the Village.

Mr. Sager responded that they do not all have to live in the Village for the Housing Authority, but do for Planning and Zoning and these two candidates do.

The Village's annual Litter Pluck is this Saturday from 9-2 this weekend. We are asking that as many that are made willing, please come out and participate to help get the Village clean. We will provide bags and gloves out of the Ted Stroebele building.

Department Head Reports

Roy Richardson-B & L-Update on Village Projects

Mr. Richardson updated the new Board members on the status of the current Village Projects

Discussion-OGS Quick Quotes

As per Mr. McMichael, this is a bid process through the State which is much easier for everyone and is fair. All we have to do is input our information and they take it from there. There are companies already registered with the State and the information goes directly to them automatically and they bid it through the State and then we are notified of the lowest bidder. They bid all products, milling, reclaiming, paving, we can do any and everything through them. I just need the Boards approval to utilize them.

We still have the chips money from last year and did not lose it, and I am sticking with the same roads from last year for that monies, Morris, Thomas, South, Floral and York Street Extension. These roads have not been done in years and the reality is, they pay taxes just like everyone else. Last year we ran out of time due to the weather and we were on the tail-end. This year, we will be ahead of the game for last year, but again running behind with this years, hopefully

weather permitting, we can get it all done.

Discussion-Energy Performance Group Contract

Representatives was present from the company, they are awaiting the contract approval from the Village in regards to the street lights. A plan was submitted months ago that will save the Village over \$500,000.00 over time. The Village is responsible for paying \$30,000.00 initially.

Michael Davidoff stated that this has been before the Village for a while now and the Village needs to make a decision.

Trustee Rue stated that she still believes that the Village needs to look at other avenue' like NYSPA (New York State Power Authority) with the Town of Thompson and the County, it's not a good thing to just go with one company.

Mr. Sager stated that he spoke with the Town and they have not actually gone with NYSPA, they did speak with them and are looking into other companies, but they have not decided on a company and they have not partnered with anyone.

He stated that he knows that EPG has not had a chance to sit with Trustee Massey due to the death in her family and discuss their proposal to her, as they have with Trustee Sommers, so it recommended that Trustee Massey be given a chance to meet with them to give them that chance. She is not expected to vote without any knowledge of their program. Hopefully after she is informed, the Board will be more ready to move forward with this project.

We got in trouble for doing this, and now because it's a different face, it's okay. No, DA, no uproar, nothing, if I hadn't said nothing, it was going to be voted without question.

Mr. Sager stated that he knew nothing about it and that this is his first time seeing this. The Clerk opens the bids and he has nothing to do with it.

The Village Clerk responded that she has nothing to do with the Justice Court and she does not open their bids, she gets everything last and it goes through the process starting from the Department heads through everyone else before she gets it.

Mr. McMichael, responded that they will be doing basic yard work, raking, push lawn mower, litter-plucking, weed-whacking, they cannot operate the motor equipment due to the requirements under Civil Service and the CBA.

Trustee Massey responded, the work that your guys don't want to do.

Mr. McMichael responded that his guys will be doing road work and repairs and so on, also pitching in with these duties when it's slow.

The whole formula and everything is done through the State and also located on their website. We have done it in the past when others were in office and this is no different.

Trustee Massey asked how we know that she honestly put in these hours, how were they documented.

The Village Treasurer responded that any Trustee can claim their hours through this process and we hope that they are honest enough to do the right thing, the Clerk provided all of the backup in the packets, I sat with her and we went over all of this step by step and it was all calculated correctly. We broke it down to make it as simple as possible.

Trustee Rue stated that this has been done for other Trustee's in the past and she is entitled to this time.
