Trustee Rue commented that the Treasurer does not have the authority to submit anything to anyone without the Boards approval or input. Now, the Village is out of another almost \$20,000.00 that we could use for that building.

Mr. Lasher responded that as Michael said, there were time constraints and we could not wait to get everyone's input, it had to be done, so I did it, it's done and that's it.
