We are still looking for a place to move the Justice Court which is one of the requests of the YMCA's movement into the building because they are looking to utilize the entire space.

Trustee Rue commented that then there is no need to have this agreement in front of us to vote for tonight. If there are still just talks going on, why are we voting and on what? What are the talks about the Justice Court move, where is it going, is the Judge involved, who attends these meetings.

Mayor Sommers commented again, as I stated, this MOU is only to move forward, this is not a contract, we are too premature in the discussions to even be headed that way. We are obligated to fix the roof and fix some other on-going issue's that have been at the Ted Stroebele for years. This MOU again is simply stating that we are willing to hold up our part of the bargain in regards to those building issues and repairs, that's it.
