Mayor/Manager Report

Mayor Sommers made the Board and Public aware that there was an error in the totaling of the tax bills made by the preparer. When the final bills were totaled the 10% that is usually collected in February was added in. The Village Clerk has reached out to the company that prints the bills, Telascent, to see how to remedy this issue quickly. As of right now, anyone that has paid their taxes, the Village will be refunding any and all overpayments. It will take some time to get to the refunds sue to the volume of taxes we collect, but you will be refunded. In the meantime, I have asked the Village Clerk to prepare a Press Release and send it out stating exactly what I have said here to all of you. We are aware of the issue and are trying our best to get it remedied as promptly as possible.

Discussion-Proposed Zoning Code Revisions

Richard S. Baum, Deputy Village Special Council and Village Engineer, Glenn Smith, were present and gave the Board a presentation of the Zoning Code Revisions that was completed by the Planning Board for their review and input regarding the 2018 Sullivan County Business

Friendly Zoning Grant. The Village received a \$13,000.00 grant and has a 25% match, the requirement is to made changes to the Code and it is due in October 2019. Mr. Baum made the Board aware that this is a Type I Action, a long Environmental Assessment Form (EAF) will need to be completed along with a Negative Declaration once we reach that point.
