Mayor Nikolados made the Board and Public aware that he has been working on the \$10,000,000.00 Downtown Revitalization Grant with the County Planning Department, Town of Thompson and Sullivan Renaissance that is due on September 15th. Stated that he feels that we have a better chance at it this year being that there is a lot more going on in the Village, we a able to present a much stronger application.

The CFA application has already been turned in for the North Street Commons that the Board voted in support of a few weeks ago.

Lastly, Trustee Banks put together a small committee and they will be handing out back-packs for school on Saturday, September 5th from 10am to 2pm at Low Profile Barber Shop located on Broadway.

Resolution authorizing the payment of the Village Bills in the amount of \$67,697.61

A motion was made by Trustee Banks with a second by Trustee Rue to pay the bills. Upon the call of the roll, all present were in favor.

Resolution authorizing the Waverly Avenue Bridge Proposal from Barton & Loguidice for Engineering Services not to exceed \$49,700.00 and authorizing the Mayor to execute the authorization to proceed on behalf of the Village of Monticello

Trustee Massey asked why the Village has to put in for this, if this is a County project.

Mayor Nikolados explained that this was the plan that we came up with the County. They are paying for all of the work and materials. All we are paying for is the plans, which are far less than the County's bill. Plus, we have infrastructure that runs under this bridge and we cannot afford to move all of that stuff in order for them to fix the bridge, so this is our contribution for them allowing us to leave our piping and drains where they currently are and the Bridge that is in the Village on a Village street, will be fixed.
