those dug up and relocated, and the County asked that we pay the cost of the design phase. This \$47,000.00 is much cheaper than having those pipes relocated and also the County is paying way over \$300,000.00 for the rest of the project, this is our only contribution.

These pipes were on the Village, not the property owner so we had to correct the problem and my department didn't have the proper equipment to be able to complete the work and this company was the cheapest. We used money from the Contingency fund because we didn't have anywhere else to pull it from. Hopefully this is the only time we need to dig into it.
