Mayor Report

Mayor Nikolados reminded everyone of the Juneteenth Parade scheduled for Saturday, June 18th, 2022 and admonished everyone to please attend and support this event.

<u>Discussion-\$1,000.00 donation from Village of Monticello to NAACP for Juneteenth</u>

Trustee Banks stated that he was hoping that the Village will be able to donate \$1,000.00 to the NAACP because they ran short and are not available to cover all of their cost.

Mr. Sussman made everyone where that the Village is not allowed to donate finances, it is not a legal process. He stated that he spoke with someone that is willing to donate the \$1,000.00 on behalf of the Village so that it does not come from the Village coffers.

Discussion-Warming Center at TSC

Mr. Snowden made the Board aware that there have been issues with having the Warming Center at the TSC in regards to vandalism and destruction and wanted to know if the Board wanted to continue have it there.

After a discussion of the Board, Mr. Snowden was advised to speak with the County and set up stricter parameters for the care of building and also the rising cost of fuel and electric.

Discussion-Dumping behind DeHoyos Park by Contractors working for Village residents

Mr. Snowden stated that he observed constant traffic to the dumping grounds behind DeHoyos Park and is concerned for the children and work that is taking place at the park. He does not want to see anything happen or an accident tack place and the Village be liable for the negligence of monitoring the dumping. He made the Board aware that as of right now, he has suspended it and he has locked the gate. He went on to say that those that are dumping are hired contractors that are being paid by Village residents to do work and when they finish, they come to DeHoyos Park and dump all of their brush and debris for free. We should be able to charge them a fee or something, they need to have worker's comp insurance Right now, it's a free for all and yet again, the Village is being taken advantage of and will be the ones responsible if something happens.

The Board agreed with Mr. Snowden and directed him to come up with a permit, fees and requirements and so on to dump and then they will look to take action in the next meeting.
