Motion to accept the agenda

Questions were asked regarding water and sewer capacity, how the Village plans to move forward if an emergency occurs, when will the upgrades to the Water Plant take place, and will capacities be increased.

Mr. Baum replied that all of the current projects before the Planning & Zoning Board have already been factored into the water & sewer capacity counts. There are also agreements that have been put in place for studies of the village water capacity and infrastructure. Developers put a minimum of \$10,000.00 into an escrow fund that was to pay for these studies that was completed by Delaware Engineering. Reports came back stating that the Village has water, it is a matter of getting it from the well fields to the plants and residents. He also stated that there is a rigorous treatment process that all the water goes through that comes out of Kiamesha Lake, which the Village owns, so that the water is clean to drink and use. If an emergency does come up, the Village residents will get first preference and then all of the projects, we are not looking to have an issue like Fallsburg and we are already taking measures to mitigate that.

Mr. Snowden explained that as of right now, the Water Plant project will be going out to be bid very soon, but that will not be competed for a couple of years. He also stated that the new plant will not have an increase in capacity because the DEC will not allow for that. If we were to aske for an increase in capacity, that could put the project off for another couple of years. As Mr. Baum explained, the Village has water, it's just a matter of getting the wells working in the well field on Park Avenue.
