Discussion-Parking on Spring Street

There was a discussion of the Board regarding the parking and congestion on Spring Street due to the fact that it's a one-way street halfway and then you must turn right on to Washington Street or keep going straight.

Highway Supervisor, Jay Sherb suggested that their either be no parking at all or only allow parking on Sundays for those that attend the churches located on that street from 6am to 12noon or just do no parking at all times on either side.

A motion was made by Trustee Hutchins with a second by Trustee Davis to set up a Public Hearing for July 16th at 6:15pm for no parking on either side of Spring Street except for Sundays. Upon the call of the roll, all present were in favor.

Motion to Adjourn the regular meeting & Open a Budget meeting

A motion was made by Trustee Hutchins with a second by Trustee Davis to adjourn the regular meeting & open a Budget meeting at 5:10pm. Upon the call of the roll, all present were in favor.

Mayor Massey asked the Board if they had any questions for the Department Heads regarding the Tentative 25/26 Budget.

Mr. Snowden responded that he spoke with Mr. Sherb regarding the increase in sanitation fees in the amount of 20% and he is in full agreement. The sanitation fund struggles the most because it has a lot of expenses, but makes very little money, also with this new 25% increase from the County for the Tipping Fees, a 20% increase is the only way we can afford it and hopefully balance that fund out. He stated that we also need to go up at least 3-5% on the quarterly water bills, we will be building or improving our water plant and going out to bid soon, so doing the increase now, will assist us for the incoming expenses not covered by the grants and that will also end up on out taxes in the next, 26/27, fiscal year.

Trustee Hutchins stated that he is a Village tax payer too and that 20% increase is stiff and then increase in water, but he understands the necessity of it. The Village is being hit very hard from all sides and we have to find a way to recoup it, especially with the County going up in the tipping fees and all of these contracts, raises and improvements; our goal is to pass a balanced budget and these increases along with the proposed tax increase is the only way we can do it, and honestly, we are still not out of the woods, but we will gain a little head way.

Mayor Massey stated that she is not happy with the increases, but they have to be done. The previous administration left us in a deep, dark hole and we have to find a way out, we have these huge contracts with these increases, some up to 6% for the next two years and we have more expenses than money and we cannot get out of these union contract. I am not happy, but this is what we have to do. If no one has any other issues to discuss, we can close this portion of the meeting and return to our regular agenda.

Close the Budget Session

A motion was made by Trustee Hutchins with a second by Trustee Davis to close the budget meeting & return to the regular meeting at 5:32pm. Upon the call of the roll, all present were in favor.

Resolution of Adoption for the 2025/2026 Village Budget

A motion was made by Trustee Davis with a second by Trustee Hutchins to approve the 25/26 Village with a 9.5% tax increase and a 5% increase in the water and sewer bills. Upon the call of the roll, all present were in favor.

Resolution authorizing payment of the Village bills in the amount \$211,477.80

A motion was made by Trustee Hutchins with a second by Trustee Davis to pay the Village bills. Upon the call of the roll, all present were in favor.

Resolution authorizing a Correction of Errors for SBL#108.-1-1 & 108.-1-2 for tax years of 2021, 2022, & 2023 in the amount of \$13,114.21 for Jody & Brenda Farquhar from app#A.0250 (General. Current Tax Receivables) and making him an outside water user

Trustee Hutchins asked was the monies figured out or totaled in regards of him being an outside user?

The Village Clerk responded yes, everything was totaled and also deducted from this amount and he is being paid the balance. Those monies will be transferred to the water fund and he will more than likely have a credit on his account.
