Local Law No. ____ of the year 2021

A local law to amend the Village Code

Be it enacted by the BOARD OF TRUSTEES of the

Village of MONTICELLO, as follows:

The purpose of this Local Law is to amend Chapter 252. Vehicles and0 Traffic of the Village of Monticello Code, as follows:

§ 252-18. All-night parking.

Amend to read as follows:

“The parking of vehicles is hereby prohibited on all highways within this Village between 10:00 p.m. and 6:00 a.m. from November 15 of each year to April 1 of the following year.”

§ 252-19. Parking prohibited at all times in certain locations.

Add the following:

§ 252-30. Authority to impound vehicles.

Amend the entire sub-section to read as follows:

A. When any vehicle is parked or abandoned on any highway within this Village during a snowstorm, flood, fire or other public emergency which affects that portion of the public highway upon which said vehicle is parked or abandoned, said vehicle may be removed by the

Chief of Police or Highway Superintendent by utilization of the provision of Chapter 236(16) of the Village of Monticello Code.

B. When any vehicle is found unattended on any highway within this Village where said vehicle constitutes an obstruction to traffic, said vehicle may be removed by the Chief of Police or Highway Superintendent by utilization of the provision of Chapter 236(16) of the Village of Monticello Code.

C. When any vehicle is parked or abandoned on any highway within this Village where stopping, standing or parking is prohibited, said vehicle may be removed by the Chief of Police or Highway Superintendent by utilization of the provision of Chapter 236(16) of the Village of Monticello Code.

§ 252-33. Delegation of duties.

Amend the entire sub-section to read as follows:

A. Any of the duties of the Police Chief under this article may be delegated by him to other members of the Police Department of the Village.

Add (B.) as follows:

B. Any of the duties of the Highway Superintendent under this article may be delegated by him to other members of the Highway Department of the Village.

This Local Law shall take effect on _____ so long as it is filed in the Office of the Secretary of State before such date in accordance with section 27 of the Municipal Home Rule Law.
