The Project consists of constructing a new raw water intake and pumping facilities, chemical storage and feed systems, and finished water pumping, clear well, and new SCADA system. Bids shall be on a unit price and lump sum basis as indicated on the Bid Form.

Bids will not be accepted from Bidders that have been barred from competing on public works under General Municipal Law 5A-103-b.

Purchases made by **Village of Monticello** are not subject to any Federal, State or local sales tax. Bidders shall not include in their bid sales and compensating use taxes on the cost of materials. Exemption certificates will be executed upon request.
